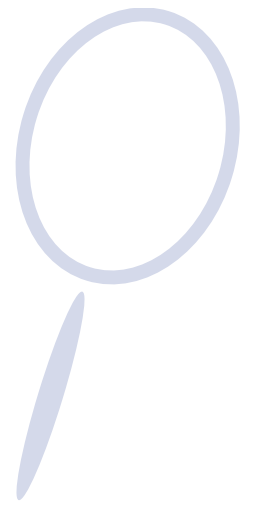

Why Does This Problem Exist?

The average tax preparer spends less than 45 minutes preparing a return. Due to all the tax preparation competition, tax preparers can only charge a fixed fee. Therefore, they can only spend a limited amount of time preparing your tax returns. Additionally, the average tax preparer handles 480 tax returns in a 2 1/2 month window, known as tax season. Nearly 60% of all returns are prepared in the last month, prior to April 15th, because Americans typically procrastinate on getting their taxes completed. This puts great stress on tax preparers. Mistakes can be made, deductions may not have been taken advantage of. **There is a 60-70% chance that you may have overpaid your taxes unknowingly.**

Other reasons include:

- ✓ There are 50,000 pages of tax code!
- ✓ Last year alone there were 430 tax law changes!

Money Magazine's Annual Tax Test

Money Magazine annually submits a hypothetical family's records to 30 to 50 different tax preparers. All records submitted were identical. The results weren't! Listed below are taxes prepared for 8 different years.



Results: There is an average discrepancy of over 300% in what these tax preparers state is due.

Money Magazine asked 50 professional tax preparers 10 basic tax questions. The results were:

- None of the 50 preparers aced all 10 questions.
- Only 34 got at least half the questions correct.
- Only 18 could define provisional income.
- Only 6 knew the changes to AMT. (Alternative Minimum Tax)
- Only 1 knew tax-exempt bonds are taxed as ordinary income.

It's difficult for tax preparers to keep up on all the new annual tax laws and guidelines. It's not just tax preparers who are overwhelmed by the 50,000 pages of tax laws. The May 15, 2001 issue of The Wall Street Journal reported that the Treasury Inspector General found that the IRS gave incorrect and **insufficient advice 73% of the time**. The IRS countered that their audit of 544 centers reported **ONLY a 50% error rate!**

With the IRS giving incorrect information over half the time, how can you be sure that your tax returns are accurate every year? *Unfortunately, you can't.*

What about an Audit?

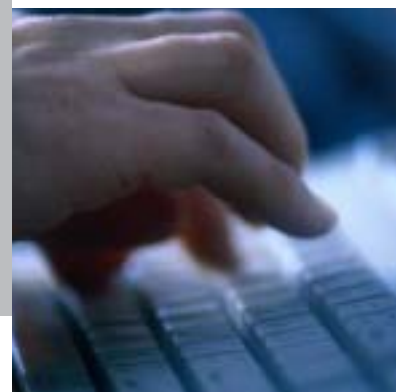

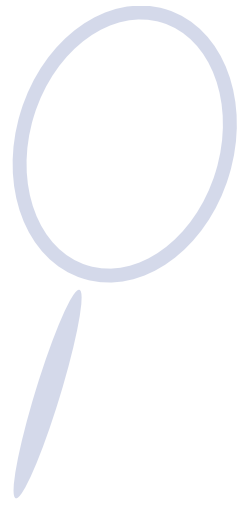
